### Privacy Summary

We collect contact details you provide, such as your name, email, or phone number; and information about how you interact with our website, including the pages you visit. If you are receiving care from us, we also collect your health information.

We use this information to provide and coordinate healthcare services, respond to your questions or requests, and improve our website and services. With your consent, we may also send updates or newsletters.

Our website uses cookies and similar tools to enhance your experience and, with your permission, to show relevant advertisements. You can manage your cookie preferences at any time.

We do not sell your personal information. We may share it with trusted service providers, such as website hosting, analytics, and email tools, or as required by law.

You have rights regarding your personal information. You can request access, corrections, or deletion of your data and opt out of marketing communications. If you are located in California, the European Union, or the UK, you may have additional rights. As a patient, you also have special HIPAA rights related to your medical information.

We protect your information with safeguards such as encryption, secure servers, and controlled access. Our website is not directed to children under 13, and we do not knowingly collect information from them.

No mobile or messaging consent information will be shared with third parties/affiliates for marketing/promotional purposes. All the above categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.

#### 1. Introduction

## **10. Security**

We protect your data with a combination of administrative, technical, and physical safeguards. These include encryption, secure servers, access controls, and staff training to ensure information is handled responsibly.

## **11. Data Breach Notification**

If your personal information or PHI is compromised, we will notify you and regulatory authorities as required by applicable law, including HIPAA/HITECH, GDPR, and state regulations.
